1. HOW TO ENTER

- a. These rules govern the “Qantas Airways / Destination NSW Flyaway to Mardi Gras in Sydney, Australia” promotion (“Promotion”), which is being conducted by KMVQ-FM (“Station”). The Promotion begins on Tuesday, January 23, 2018 and ends on Sunday, February 4, 2018 (“Promotion Dates”).
- b. To enter the Promotion, entrant may enter online beginning on Tuesday, January 23, 2018 at 5:00pm PT and ending on Sunday, February 4, 2018 at 11:59am PT (“Entry Period”).
 - i. To enter online, visit www.997now.com and follow the links and instructions to enter the Promotion and complete and submit the online entry form during the Entry Period. All eligible participants must secure the five (5) required scavenger hunt items listed on website and upload them as a photo collage. Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address. Multiple participants are not permitted to share the same email address. P.O. Boxes are not permitted. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Promotion administrator.
- c. There will be up to a total (1) grand prize winner selected at the conclusion of the Promotion
- d. Due to delays in the online streaming of the Station’s broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests. Entrants are encouraged to listen to the Station on-air. The Station is not responsible for online streaming delays of any nature.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are legal U.S. residents, 21 years of age or older and who reside in one of the nine (9) county jurisdiction that makes up the Greater San Francisco / Bay Area (San Francisco, Santa Clara, Alameda, Contra Costa, Marin, San Mateo, Solano, Napa, and Sonoma Counties. Void where prohibited or restricted by law. Employees of Qantas Airways and Destination NSW., officers, directors and agents of the Station, Bonneville International Corporation (BIC), their corporate affiliates, Station's advertising and promotional agencies, participating sponsors, prize suppliers, their respective affiliates (collectively, the "Promotion Entities") and other radio stations in the San Francisco metropolitan area, the members of their immediate families (spouse, parents, siblings or children) and those living in the same household of each (whether related or not), are ineligible to enter or win. This Promotion is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station(s), which are final and binding in all respects.

- c. The winner must provide valid government-issued photo identification and provide their complete address, date of birth and phone number, and Social Security Number to claim a prize.
- d. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.

3. PRIZES

- a. One (1) grand prize will be awarded. The grand prize is a nine (6) day / eight (5) night vacation (not including air travel time) for two (2) to Sydney, Australia, courtesy of Qantas Airways and Destination NSW. Some restrictions apply. The grand prize includes the following: (i) Two (2) round-trip coach fares between a San Francisco International Airport and Sydney, Australia; (ii) four (4) nights twin share accommodation in a Sydney, Australia hotel; (iii) Two (2) Grandstand Tickets to the Sydney Gay & Lesbian Mardi Gras Parade; (iv) Two (2) tickets to the Mardi Gras Party; (v) Two (2) tickets to the Laneway recovery party street celebration; (vi) Small group nature tour and overnight in the World Heritage listed Blue Mountains National Park; (vii) Wine tasting, gourmet cuisine tour and overnight in the Hunter Valley Wine Country. The ARV of the grand prize is \$4,995.00, but may vary depending on travel origination and fares in effect at the time of departure. Certain restrictions shall apply to the vacation packages, which restrictions shall be determined by Bonneville

International Corporation (BIC) and Qantas Airways and Destination NSW in its sole and absolute discretion. The vacation packages (and all elements thereof) are not redeemable for cash and are non-transferable except in the sole and absolute discretion of Bonneville International Corporation (BIC), Qantas Airways and Destination NSW. The vacation packages may not be sold or transferred to any other person or third party. The grand prize must be completed between Wednesday, February 28, 2018 and Thursday, March 8, 2018. Travelers must be at least twenty-one (21) years of age and have a valid United States issued Passport. The grand prize may not be sold, traded, transferred, and rescheduled to dates other than as set forth above. Certain travel restrictions apply. Arrangements must be made through Qantas Airways and Destination NSW. Expiration dates will not be extended. Qantas Airways and Destination NSW, its parent, subsidiary, related and affiliated companies, and their respective officers, directors, employees and agents shall be released and discharged from any and all legal claims, losses injuries, demands, damages, actions, and / or causes of actions which arise out of and / or in any way related to the prize, the receipt, use and / or enjoyment of the prize and / or promotion. The Station(s) is not responsible for the safe arrival of a prize(s) or prize certificate(s).

- d. Prize(s) is not transferable, and no substitution, assignment or cash equivalent of prize(s) is permitted, except by the Station (solely at its discretion), which reserves the right to substitute a prize or prize portion with another prize or prize portion of greater or equal value. The prize(s) are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Promotion Entities are not responsible for winners' limitations that prevent acceptance or use of prize(s). The Prize(s) is provided as is. Entrants acknowledge that the Promotion Entities have not made, and are not in any manner responsible or liable for, any warranties, representations or guarantees, and hereby disclaim any and all warranties, expressed or implied, whether by contract or law, concerning any prize, including without limitation, implied warranties of quality, merchantability, mechanical condition or fitness for a particular purpose, with the exception of any standard manufacturer's warranty that may apply. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Promotion are final.
- b. One (1) grand prize winner will be selected on February 5, 2018 at approximately 12:00pm PT in a random drawing of all qualifying prize winners.
- c. Odds of winning the grand prize depend on the number of eligible online entries received
- d. The grand prize winner does not need to listen to the Station(s) or be present to win.
- e. Potential grand prize winner will be notified by telephone on or around February 6, 2018 at approximately 7:00am PT. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. The winner(s) must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize(s) will be forfeited. If a winner has not reached the age of majority in his/her state of residence, the prize(s) will be awarded in the name of his/her parent or legal guardian. If the Promotion is terminated before the original end date, the Station reserves the right, in its sole discretion, to modify the procedure for selecting winner(s), unless the nature of the event giving rise to such termination renders it impossible to select winner(s).
- e. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize(s); (ii) incorrect or inaccurate entry information, human error, failure or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, postage due, illegible, incomplete, unsuccessful, or late entries or

notifications; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone or text message service outages, delays, busy signals, poor signals or signal interference, accidental disconnection or equipment malfunctions or any other technological problems or failures of any kind; or (vi) any cancellations, delays, diversions, substitutions or omissions whatsoever by any transportation providers or any other persons or entities providing any services to winner(s) (and guest(s), if applicable) including any results thereof such as changes in services or location necessitated by same. Further, the Released Parties are not responsible if any part of a Promotion prize cannot be awarded due to acts of God, acts of war, natural disasters, weather, acts of terrorism or other factors beyond the Released Parties' control.

- f. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address or (ii) is assigned to the text or mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Promotion. Failure to comply with the rules of the Promotion may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station may disqualify that entrant from entering and/or winning this and any or all future Station-administered Promotions and seek damages to the fullest extent permitted by law.
- g. The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the Promotion, including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Promotion Entities, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel, terminate, suspend or modify the Promotion and shall not be required to award a substitute prize(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the Contest webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.

- h. Except where prohibited, by entering the Promotion, each entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize(s) awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in San Francisco, CA; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event shall such costs include attorneys' fees; and (3) no punitive, incidental, special, consequential or other damages, including, without limitation, lost profits may be awarded (collectively, "Special Damages"), and (4) entrant hereby waives all rights to claim Special Damages and all rights to have any damages awarded multiplied or increased. New York law governs the interpretation and construction of these Official Rules and all aspects related thereto.
