#### 1. HOW TO ENTER

- a. These rules govern the 99.7 NOW! Universal Studios Halloween Horror Nights ("Contest"), which is being conducted by KMQV 99.7 NOW! ("Station"). The Contest begins on Saturday, October 6 and ends on or around Saturday, October 13, 2018 ("Contest Dates"). Entrants may enter on-air only.
- b. To enter the Contest, entrant may enter on-air beginning on Saturday, October 6, 2018 AND beginning at 12:00PM PST and ending at 5:00PM PST and again on Saturday, October 13, 2018 beginning at 12:00PM PST and ending at 5:00PM PST ("Entry Period").
  - i. To enter on-air, listen to the Station beginning on Saturday, October 6 beginning at 12:00PM PST and ending at 5:00PM PST and again on Saturday, October 13, 2018 beginning at 12:00PM PST and ending at 5:00PM PST during the Entry Period for the air personality to announce the cue to call. Upon hearing the cue to call, the NINETY NINETH (99) designated caller (as announced by the on-air personality prior to the cue to call) to get through to the Station contest line: 888-456-9970, will win a qualifying prize and will be qualified for a chance to win a grand prize upon confirmation of eligibility. At the time of entrant's call, entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller will not win a prize and the next eligible caller who successfully makes it through on the call-in line and completes the call will be a winner. There is no limit

to the number of times a listener may attempt to call in to win, but a listener may be a winner only once during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant.

- c. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of CA, Twenty-One (21) years of age or older, and who reside in one of the NINE (9) jurisdictions that makes up the listening area who reside in one of the Greater San Francisco / Bay Area (San Francisco, Santa Clara, Alameda, Contra Costa, Marin, San Mateo, Solano, Napa, and Sonoma Counties. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. Unless the Station otherwise specifies, in its own discretion, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize valued up to \$100 in the last thirty (30) days are not eligible to participate. The Approximate Retail Value ("ARV") of the prize(s) is \$194.00. Tickets must be used by November 3, 2018. Tickets must be used on one of the following dates: October: 11, 12, 13, 14, 18, 19, 21, 24, 25, 26, 27, 28, 31 OR Nov 1, 2, 3.
- b. ONE (1) grand prize will be awarded in the Contest. The grand prize is two (2) tickets to Universal Studio's Halloween Horror Nights, One (1) Night Stay At Sheraton Universal Hotel, Two (2) Premium Tickets To Jabbawockeez Show "Jreamz" at MGM Grand (tickets are not valid on Saturdays or Holidays), Additional Post Show "Meet And Greet Experience" Two (2) Night Stay At MGM Grand Hotel Las Vegas! The estimated retail value of the vacation package is \$900. Vacation is for the winner and one (1) guest of the winner's choosing. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of

the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station/judges are final.

- d. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.
- b. TWELVE (12) qualifying prize winner(s) and ONE (1) grand prize winner will be selected on-air, as described above in Section 1 of these Official Rules.
- c. Odds of winning a qualifying prize depend upon the number and order of eligible phone calls received. Odds of a qualifying prize winner winning the grand prize are one (1) in TWELVE (12)
- d. Winners must listen to the Station to win but do not need to be present to win. All prizes may be picked up at the office of the Station at 201 3<sup>RD</sup> STREET, SUITE #1200, SAN FRANCISCO, CA, 94103 between regular business hours of 8:00 a.m. 5:00 p.m. If a winner chooses to have a prize shipped, the Winner will be required to sign a release that the Station and any Released Parties (defined below) are not responsible if the prize is late, lost, stolen, misdirected, undeliverable, or damaged during shipping. In such cases, there is no purchase necessary to enter or win, except for reasonable postage and handling fees the amount of which shall not exceed \$1.50 plus the actual cost of postage to ship the prize.
- e. Potential winner(s) will be notified of winning by telephone at the time of the drawing. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases.
