1. HOW TO ENTER

- a. These rules govern the "Big Money Minute" promotion ("Promotion"), which is being conducted by KMVQ-FM ("Station"). The Promotion begins on Monday, September 9, 2019 and ends after \$10,000 has been awarded, whichever happens first ("Promotion Dates").
- b. To enter the Promotion, entrant may call and be the designated caller beginning on Monday, September 9, 2019 at approximately 6:10am PT and ending or after \$1,000 has been awarded ("Entry Period").
- b. To enter on-air, listen to the Station each weekday beginning on Monday, September 9, 2019 and ending after \$1,000 has been awarded, whichever happens first at approximately 6:10am, 7:10am and 8:10am, during the Entry Period for the announcement of the cue to call announced by the on-air personality. Upon hearing the cue to call, Caller nine (9) will have to answer 10 (ten) random trivia questions within one (1) minute. Contestants will be given the opportunity to answer ten (10) questions for the chance to win a jackpot of \$1000. All ten (10) questions must be correctly answered to win the grand prize. If the entrant uses Google or has help in anyway, the contest will end and entrant will be disqualified. At the time of entrant's call, entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller who successfully makes it through on the call-in line and completes the call will be a winner after successfully. There is no limit to the

number of times a listener may attempt to call in to win, but a listener may be a winner only once. Proof of submission of an entry shall not be deemed proof of receipt by the Promotion administrator.

- c. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests. Entrants are encouraged to listen to the Station on-air. The Station is not responsible for online streaming delays of any nature.
- d. Entrants may be provided with an opportunity to opt-in for membership / participation as part of the entry process, but membership / participation is not required to enter the contest.
- e. Only one (1) entry per person is permitted. There will be a total of five (5) grand prize winners selected in the Contest.
- f. All online entries must be received by the end of the Entry Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of California, eighteen (18) years of age or older, and who reside in one of the Nine (9) jurisdictions that make up the listening area of the Greater San Francisco / Bay Area (San Francisco, Santa Clara, Alameda, Contra Costa, Marin, San Mateo, Solano, Napa, and Sonoma Counties). Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

- e. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.
- f. This Contest is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

3. PRIZES

- a. One (1) prize per winner will be awarded. The prize depends on if the contestant can correctly answer the trivia questions. Entrants who answer all ten (10) trivia questions correctly will win the Grand Prize \$1,000 depending on how many winners answer all ten (10) questions correctly. The check will be subject to the terms and conditions as set forth by its issuer. The Approximate Retail Value ("ARV") of the prize is \$1,000.
- b. All sales, prizes and other taxes, gratuities and any other incidentals associated with the prizes are the sole responsibility of the prizewinner(s). Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability, in which case, a prize of equal or greater value will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station is not responsible for replacing tickets in the event of show cancellations as a result of weather, or promoter, or performer actions. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station are final.
- c. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the contest are final.
- b. Ten (10) grand prize winner(s) will be selected on-air as described above in Section 1 of these Official Rules.

- c. The odds of winning a qualifying prize depend upon the number of phone calls, the order of eligible phone calls received and if the caller can successfully guess what the DJ is.
- d. Entries are specific to each designated Drawing Period and will not be included in subsequent drawings.
- e. Winners do need to listen to the Station to win and do not need to be present to win. All prizes may be picked up at the office of the Station at 201 3rd Street, Suite #1200, San Francisco, CA 94103 between regular business hours of 9:00 a.m. PST and 5:00 p.m. PST. If a winner chooses to have a prize shipped, the Winner will be required to sign a release that the Station and any Released Parties (defined below) are not responsible if the prize is late, lost, stolen, misdirected, undeliverable, or damaged during shipping. In such cases, there is no purchase necessary to enter or win, except for reasonable postage and handling fees the amount of which shall not exceed \$1.50 plus the actual cost of postage to ship the prize.
- f. Potential winner(s) will be notified of winning by telephone at the time of the drawing. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. system is the official time keeping device for this Contest. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. - a. In the event of conflict between the Station's Terms of Use Agreement and these Official Rules, the terms of these Official Rules shall apply. Any information that Twitter, Facebook, or Instagram collects through an entry in the Contest may be subject to Twitter's, Facebook's, or Instagram's own terms and policies.

7. WINNERS' LIST/COPY OF OFFICIAL RULES

- a. Any violation of these rules may result in disqualification. Consistent with Section 1(e), only one (1) entry per person.
