## 1. HOW TO ENTER

- a. These rules govern the 99.7 NOW 99 Stockings ("Contest"), which is being conducted by KMVQ-FM ("Station"). The Contest begins on Saturday, December 2, 2023, and ends on Friday, December 22, 2023, ("Contest Dates"). Entrants, as defined below, may enter via online and on-air only.
- b. To enter the Contest, the person entering the Contest ("Entrant") may enter via online beginning on Saturday, December 2, 2023 at 12:00am (PT) and ending on Friday, December 22, 2023 at 5:30pm (PT) at ("Entry Period").

- i. To enter online, beginning Monday, December 4, 2023 at 12:00am (PT) and ending on Friday, December 22, 2023, at 5:30pm (PT) visit [www.997now.com](http://www.997now.com) and follow the links and instructions to enter the Contest and complete and submit the online entry form (“99 Stockings Entry”) during the Entry Period outlined above. Entries are subject to all notices posted online including, but not limited to, the Station’s Terms of Use and Privacy Policy. Only one (1) Employee of the Day Entry per eligible Entrant during the Entry Period will be allowed, regardless if Entrant has more than one email address. Multiple Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Online entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Station.
- ii. To enter on-air, beginning on Monday, December 4, 2023 at 10:00am (PT) and ending on Friday, December 22, 2023, at 5:20pm (PT) listen to the Station weekdays at approximately 10:20am (PT), 11:20am (PT), 12:20pm (PT), 1:20pm (PT), 2:20pm (PT), 3:20pm (PT), 4:20pm (PT) and 5:20pm (PT) for the on-air hosts to give the cue to call. Caller twenty-five (25) into the studio at 888-456-9970 will have the opportunity to select two (2) stockings from the 99 Stockings gameboard. If the contestant matches two (2) stockings with the same prize, the contestant will win that prize. 99.7 NOW may elect at its sole discretion, to continue the contest beyond these dates if it so chooses.
- c. Due to delays in the online streaming of the Station’s broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- d. Only one (1) 99 Stockings entry per Entrant is permitted. The number of prizes awarded in this Contest depends on the number of contestants who match two (2) of the same stockings. A winner is defined as the person(s) who has been deemed eligible by the Station to win a prize (“Winner”). Only one (1) Winner, per household for the duration of this Contest is permitted.

- a. Void where prohibited or restricted by law.
- b. Decisions of the Station/judges are final.
- e. #### 4. WINNER SELECTION AND NOTIFICATION

The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address; or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest.
