## 1. HOW TO ENTER

- a. These rules govern the “KOIT-FM, KMVQ-FM, KBLX-FM, KUFX-FM Cache Creek Casino Resort – Lunar New Year 2025 Online Giveaway” promotion (the “Promotion”), which is being conducted by KOIT-FM, KMVQ-FM, KBLX-FM, KUFX-FM (the “Station”). The Promotion begins on Thursday, January 9, 2025, and ends on Wednesday, January 29, 2025 (the “Promotion Dates”).
- b. To enter the Promotion, entrant may enter online beginning on Thursday, January 9, 2025, at 12:00 pm Pacific Time (“PT”) and ending on Wednesday, January 29, 2025, at 11:59am (PT) (the “Entry Period”) as follows:
  - i. To enter online, visit [www.KOIT.com](http://www.KOIT.com) between Thursday, January 9, 2025, at 12:00 pm Pacific Time (“PT”) thru Wednesday, January 29, 2025, at 11:59am (PT) and follow the links and instructions to enter the Contest and complete and submit the online entry form during the Entry Period outlined above. At the time of entrant’s submission, the entrant will be required to provide all information requested including entrant’s full name, complete address (including zip code), day and evening phone numbers, and date of birth to be eligible to win. P.O. Boxes are not permitted. A listener may be a prize winner only once.

- ii. Only one (1) entry per eligible person during the Entry Period regardless if the entrant has more than one email address. Multiple participants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of California, twenty-one (21) years of age or older, and who reside in one of nine

(9) county jurisdiction that makes up the Greater San Francisco / Bay Area listening area (San Francisco, Santa Clara, Alameda, Contra Costa, Marin, San Mateo, Solano, Napa, and Sonoma Counties. Void where prohibited or restricted by law.

- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time, and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

### 3. PRIZES

Reservation may be limited to certain days and dates as permitted by Cache Creek Casino Resort, Standard Rooms only, and not valid on blackout dates. Reservation date must be at least 30 days out from when they are calling to make the reservation, \$200 Dining Credit will be included in their room reservation so the guest can use it at their convenience at all restaurant outlets. The Approximate Retail Value (“ARV”) of each prize is

- c. Winner will be required to provide his/her social security number and any other documentation and/or sign any documentation Station requires as determined in its sole discretion as a condition of accepting the Prize.

- e. - b. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. If any

and/or winner(s) (and winner's guest(s) if applicable) including any results thereof such as changes in services or location necessitated by same. Further, the Released Parties are not responsible if any part of a Contest cannot be conducted and/or if a prize, either in whole or in part, cannot be awarded due to acts of God, acts of war, natural disasters, weather, acts of terrorism, or other factors beyond the Released Parties' control.

- f.
